3. **CANCELLATION OF TENDER:-** Superintending Engineer,EDC-II,SRE have right reserved to any change/cancellation of tender in Corporation Interest without assigning any reason what-so-ever.
4. **CANCELLATION OF AGREEMENT:-** The Agreement shall be cancelled in case the contractor does not complete the work as per provisions, security deposited by firm shall be forfeited.
5. **EARNEST MONEY:-** Each Tender must be accompanied by the Earnest Money in the form of cash deposit through RTGS/NEFT, Which will be refunded in the event of tender being rejected. No tender shall be entertained without Earnest Money. **Cheque/FDR/CDR** will not be accepted against the Earnest Money in any case.
6. **TAXES:-** GST shall be paid extra if legally applicable.
