1. No need to send/deposit hard copy of any document related to tender in this office.
2. All required documents such as GST, PAN no. experience etc as applicable are check in all respect online first of all the Bidder/Contractors then financial part of successful Bidder/Contractors are opened. The bid of Bidder/Contractors, whose documents are not complete, will not considered and shall be rejected
3. The tender fee amount (non refundable) and EMD amount Should be transferred by RTGS/NEFT in office bank current account no. **2867002100017563**, Punjab National Bank, Moradabad Gate Chandausi, IFSC- **PUNB0286700** other transaction mode shall not be accepted and tender will liable to be rejected.
4. The Bidder should have to submit 10% Performance Bank Guarantee after successful bid according to rules of PVVNL/UPPCL in the form of RTGS/NEFT/BC/DD/BG (Bank Guarantee)/CDR/FDR/TDR form any Nationalized/schedule Bank duly pledged in favour of Superintending Engineer, Electricity Distribution Circle, Sambhal at the time of executing contract agreement (valid for the entire contract period + 6 months and extension (if any) thereof for an amount totalling 10% of contract value. The bank guarantee should also have a further claim period of 06 Months from the date of completion of the contract The refund of the contract Performance Guarantee shall be made on the completion of work and satisfactory report of the concerning Engineer In charge.
5. The earnest money shall be refunded on execution of agreement (first lowest will be adjusted towards the security).
6. Conditional tender shall not be accepted and will be rejected out-right.
7. The quantity of material/distance given in the schedule of contract may vary by 10% on either side.
8. Stock material required for the construction work shall be provided by the department. All the line material will be supplied by the department. Responsibility of work transportation of material from different stores to site of work and supervision of work to its successful completion will be that of contractor.
9. The successful tendered will have to ask his own arrangement for the carriage of material as above at his own cost and no T & P required for the said work shall be supplied by the department.
10. The work will be carried out in accordance with the direction and design given by the representatives of the Corporation and construction manual and instructions. After completion of work, the site will be inspected by the representatives of the Corporation as may be designated from time to time. If any defect found, the contractor will have to rectify the segment his own cost. If they fail to do so, the Corporation will have liberty to carryout work to remove such defect and deducted the expenses so incurred from the contractor's bill.
11. In case the contractor fails to complete the work within the specified period, the remaining work shall be got carried out by some other out-side agency and completed and the difference of the cost which may have to be paid in excess by the department shall be recovered from the contractor and the agreement will be terminated on this account.
12. The undersigned reserves the right to reject the tender without assigning any reasons thereof.
13. Theft of material from the site will be responsibility of the contractor and the cost of the material stolen shall be liable to be received from the contractor.
14. The tender is liable to be rejected if the contractor fails to quote his rate online in the BOQ schedule attached with the tender.
15. The Successful tender will be present in the office of the undersigned to execute the agreement within the period as specified by the undersigned separately from the date of issue of acceptance to this office.

16. Disputes if any will be settled by the undersigned. In case of non settlement of dispute the matter shall be referred to the Chief Engineer, Moradabad Zone Moradabad and decision of the Chief Engineer, Moradabad Zone Moradabad shall be final and binding on both the parties.
17. The contractor will make proper request to the concerning Sub-Division officer for taking the shut-down as and when necessary and the department will not be responsible for any type of mishap-panning/accident takes place during the course of completion of the work by the contractor.
18. Payment for individual work will be made after its satisfactory completion and check at site.
19. A penalty of ½ % per week subject to the maximum of the 10 % of the total value of the work for the period in which the work remain incomplete shall be levied and deducted from the bill of the contractor in case of delay of work within the stipulated period.
20. The amount of the security shall be deposited by the contractor after acceptance of the tender for the total amount of the work before execution of the agreement.
21. The Contractor shall be responsible for the proper handling of the materials any damaged of the material shall be the responsibility of the contractor and the cost thereof shall be recovered from the contractor
