**PRE QUALIFYING CONDITIONS FOR TENDERERS**

**Construction of Boundary Wall at 33/11 K.V S/S Town Hall, Hapur.**

**Tender Specification No. 52/ECDC/MRT/2022-23**

1. The Tenderer should produce experience statement showing the Name of organization, name of work, DOS, DOC, ADC, Agreement Value, Executed Value, Penalty and experience of officer with contractor during the execution of work executed in Central/State Govt. Depts, and that should not be issued by officer below class-I rank (shall be produced in Part-I).
2. Tendering firm should have experience of having successfully completed similar nature works during last 7 years ending last day of month previous to one in which applications are invited and should be either of the following (shall be produced in Part-I)
  - a. Three similar\* completed works each costing not less than the amount equal to 40% of the estimated cost of this work.
  - OR
  - b. Two similar\* completed works each costing not less than the amount equal to 50% of the estimated cost of this work.
  - OR
  - c. One similar\* completed works each costing not less than the amount equal to 80% of the estimated cost of this work.

**Similar nature work means:-**

(i)	Construction of Boundary Wall at 33/11 K.V S/S Town Hall, Hapur.	Construction of Boundary wall/Security wall/ <del>Maintenance</del> Residential/Non-Residential Building at Sub-Station like 33/132/220/400 UPPCL/any other govt./PSU Department.

3. Average Annual financial turn over during last 3 years ending 31<sup>st</sup> March of the previous financial year, should be at least 30% of the estimated cost for which practicing C.A approved Turn Over Certificate has to be submitted (shall be produced in Part-I).
4. The tenderer should submit the following certifications in Part-I in readable form and duly signed otherwise may result in rejection of bid.
  - A. Certified & self attested copy of UTR No. & other detail for tender cost & earnest money.
  - B. Valid character certificate issued by D.M/S.P, for partnership firm and Pvt. Ltd firm Character certificate of All Directors shall be submitted. Character certificate shall be valid on date of opening of Part-I of tender.
  - C. Experience certificate as stated S.No. 1 & 2.
  - D. Annual financial turn over, Balance sheet, Profit & Loss statement of the 3 years ending 31<sup>st</sup> March of the previous financial year duly issued by practicing C.A. with UDIN No.
  - E. Partnership deed in case of partnership firms.
  - F. Valid G.S.T no. of Firm
  - G. Valid I.T.R of last 3 years
  - H. Valid Pan Card copy
  - I. Valid Adhar Card copy

**Note:-**

1. Tenderes shall take all safety and precaution measures of man power deployed during execution of work. In case of any mis happening contractor shall be fully responsible for incident.
2. Part-II (Price Bid) of those tenderers, who qualify in Part-I shall be opened on a later day which shall be intimated to the successful tenderers.
