

**PRE-QUALIFYING REQUIREMENTS:**

These pre qualifying requirements (PQR) shall prevail over the pre qualifying conditions mentioned in instructions to tenderers or anywhere in the tender document.

1. **Manufacturer :-** The tenderers shall themselves be manufacturers of the tendered item.
2. **Turn Over :**  
The Bidder should have a minimum average annual turnover (MAAT) of Rs. **15.00 Crores** per annum for the best three financial years out of the last five financial years. The audited balance sheet/CA's certificate with **UDIN number** shall be enclosed in support of above, failing which the bid shall not be considered.
3. **Operational Experiences:**
  - (a) **Offered equipment should have given three years proven trouble free operational service in tropical climate** prevailing in India. The tenderer must have supplied 33 KV XLPE Cables of size 3x300 sq mm or above size during last five years to government/government undertaking/ power utilities directly or through EPC contractor.
  - (b) Any false information in the tender bid if comes to the purchaser's notice in due course of time may lead to not only the cancellation of purchase order, if placed by on the tenderer, but also imposition of financial penalty and business debarment
4. **Manufacturing experience:** The indigenous manufacturer must have manufactured at least. 50% of the tendered quantities of HT XLPE Cables of 3x300 sq mm or above sizes during last five calendar years. The manufacturing experience of only last five Calendars Years (**Year 2017, Year 2018, Year 2019 , year 2020 & year 2021**) shall be considered for eligibility of tenderer. The tenderer shall have to submit the details in following proforma.

The tenderer shall have to submit self attested copies of purchase orders & despatch instructions to substantiate the above details failing which their bid shall not be considered for opening . If tenderer does not submit the proforma & only encloses the copies of purchase orders & dispatch instructions, then their bid may not be considered.

5. **Testing Facilities:** The tenderer must have all necessary facilities at their works for carrying out such routine and acceptance tests as prescribed in the relevant ISS and any other routine and acceptance test as specified in the specification. Documentary evidence of existence of such facilities will be filed along with the tender.
6. **Type Test:**  
The firm should have type test report of the offered HT XLPE Cables size 3x300 sq mm as per relevant ISS/GTP/Technical Specification issued from CPRI/ERDA during the last 5-years period. An undertaking for Type Test Report shall not be acceptable.
7. **Performance Guarantee Period:-**The material supplied shall be guaranteed for 12 (Twelve) months Calendar months from the date of installation or of max. 18 (Eighteen ) months from the date of receipt at store center whichever is earlier, called the "Maintenance period". Accordingly BG shall be submitted for 18 months @ 1% of the value of the material.

**PRE-QUALIFYING REQUIREMENTS FOR TRIAL SUPPLIER.**

- 8.0** The bidders who qualify pre qualifying requirement for Trial Supplier, their price bid shall not be opened. However, Purchaser at his discretion may consider to award trial order of small quantity at the rates approved by the purchase committee for lowest regular supplier. The bidders who have proven design and meet the following requirement shall be considered to qualify as trial supplier.
- 8.1** **Manufacturer** :-The firm shall themselves be manufacturer of tendered item.
- 8.2** **Testing facilities**:-The tenderer must have the testing facilities for testing of Cables as per technical Specification/relevant IS.
- 8.3** **Turnover**:-  
Minimum average annual turnover (MATT) of best three financial years out of last five financial years should be more than Rs. **5.00 Crores**. The audited balance sheet/CA's certificate with UDIN number shall be enclosed in support of above, failing which the bid shall not be considered.
- 8.4** **Operational Experience**:-  
(a) **Offered equipment should have given one year proven trouble free operational service in tropical climate** prevailing in India. The tenderer must have supplied 33 KV XLPE Cables of size 3x300 sq mm or above size during the last five years to government/government undertaking power utilities directly or through EPC contractor.  
(b) Any false information in the tender bid if comes to the purchaser's notice in due course of time may lead to not only the cancellation of purchase order, if placed by on the tenderer, but also imposition of financial penalty and business debarment.
- 8.5** **Manufacturing experience**: The indigenous manufacturer must have manufactured at least. 20% of the tendered quantities of HT XLPE Cable of 3x300 sq mm or above sizes during last five calendar years. The manufacturing experience of only last five Calendars Years (**Year 2017, Year 2018, Year 2019 , year 2020 & year 2021 only**) shall be considered for eligibility of tenderer. The firm shall have to submit the details of manufacturing of HT XLPE Cables during last five Calendars Years in following proforma :-

The tenderer shall have to submit self attested copies of purchase orders & despatch instructions to substantiate the above details failing which their bid shall not be considered. If tenderer does not submit the proforma & only encloses the copies of purchase orders & dispatch instructions, then their bid may not be considered.

**9.0 Testing Facilities:**

The tenderer must have all necessary facilities at their works for carrying out such routine and acceptance tests as prescribed in the relevant ISS and any other routine and acceptance test as specified in the specification. Documentary evidence of existence of such facilities will be filed along with the tender.

**10 Type Test:**

The firm should have type test report of the offered HTXLPE Cables size 3x300sq mm as per relevant ISS/GTP/Technical Specification issued from CPRI/ERDA during the last 5 year period. An undertaking for Type Test Report shall not be acceptable.

- 11 Performance Guarantee Period**:-The material supplied shall be guaranteed for 36 (Thirty Six) months Calendar months from the date of installation or of max. 42 (Forty Two) months from the date of receipt at store center whichever is earlier, called the “Maintenance period”. Accordingly BG shall be submitted for 42 months @ 1% of the value of the material.
- 12 Factory Inspection**: Factory inspection shall be carried out by representative of S.E (MM-1) PVVNL, to ensure the capability of manufacturing of cable.

*All statements and claims regarding turnover, operational and manufacturing experience should be duly supported by authenticated copies of documents without which the tender is liable to be rejected summarily. PVVNL may call the tenderer to produce original purchase order/despatch instruction or any other document for verification of submitted documents during the evaluation of their bid. The bidder is also required to submit an affidavit on stamp paper regarding the firm not being blacklisted by any government utility any where in India. If any information provided by the bidder is found to be concealed, suppressed or incorrect at the later date, may lead to not only the cancellation of purchase order, if placed by on the tenderer, along with imposition of financial penalty and business debarment.*
