Subject: Blacklisting of M/s Badshah Energies for breach of contract against P.O no. 01/
Fuel-213/RGTPP/2020-21 dated 29.09.2020 for supply of torrefied Bio-mass
pellets.

In continuation to above references, it is intimated that Purchase Order was placed on your firm for supply of 800 MT torrefied Bio-mass pellets to RGTPP with a delivery period of one year from the date of issue of purchase order vide P.O. No. 01/Fuel-213/RGTPP/2020-21 dated 29.09.2020. Out of 800 MT, you merely supplied 94.86 MT of torrefied Bio-mass pellets but you failed to supply the balance contracted quantity as per terms of the purchase order. You were requested to supply the balance contracted quantity through various correspondences dated 14.10.2020, 09.11.2020, 08.12.2020, 11.12.2020, 14.12.2020, 01.01.2021, 16.01.2021, 31.03.2021, 07.04.2021, 09.06.2021, 13.07.2021 & 27.07.2021 and notice was also issued on 03.08.2021.

Accordingly a show cause notice was also served to your firm to appear before Project SPC in-person within 3 working days i.e. latest by 22.03.2022 to present your side failing which it will be assumed that you have nothing to say in this matter and action to blacklist your firm shall be initiated for breach of contract, but you did not appear before SPC in reference to the said show cause notice. The above act of your firm has tantamount to loss of faith.

In consideration of the above facts, HPGCL decides that your firm is hereby blacklisted from doing further business with HPGCL up to 14.09.2023 for not supplying the balance contracted quantity as per aforesaid Purchase Order.

This is without prejudice to any other rights and remedies available to HPGCL.
