2. The tenderers may obtain further information / clarification, if any, In respect of these tender documents from the office of Superintending Engineer, EUDC-II, Sector – 18, Noida.
3. The Intending bidders must be registered on e-tendering portal www.etender.up.nic.in. Those who are not registered on the e-tendering portal shall be required to get registered beforehand. If needed they can be imparted training on online tendering process'. After registration the tenderer will get user id and password. On login tenderer can participate in tendering process and can witness various activities of the process.
4. The authorized signatory of intending bidder, as per Power of Attorney (POA), must have valid class-III digital signature. The tender document can only be downloaded or uploaded using Class-III digital signature of the authorized signatory.
5. E-tenders are invited in two parts (Part-I Techno Commercial Bid and Part II Price Bid) for the above work. 6. Tenderer is cautioned that the tender containing any material deviation from the tender document which consists of NIT, Instructions to tenderers, General conditions of contract, Special conditions of contract, Bill of quantities is liable to be summarily rejected as non-responsive.
7. Unless explicitly stated otherwise in the Tender Document, the contractor shall be responsible for the whole works, based on the Bill of Quantities and payment shall be as per accepted rates based on the activities carried out as in the Schedule of work.

13. The SE EUDC 2 Noida may waive any minor informality, nonconformity or irregularity in a bid that does not constitute a material deviation, whether or not identified by the Bidder in its bid, and that does not prejudice or affect the relative ranking of any Bidder as a result of the technical and commercial evaluation.
14. Prior to the detailed evaluation, the SE EUDC 2 Noida will determine whether each bid is of acceptable quality, is complete and is substantially responsive to the Bidding Documents. Any deviations, conditionality or reservation introduced will be reviewed to conduct a determination of the substantial responsiveness of the bidders bid. For purposes of this determination, a substantially responsive bid is one that conforms to all the terms, conditions and specifications of the Bidding Documents without any material deviations, objections, conditionalities or reservations and complies with all the statutory laws in force as amended from time to time. TERMS AND CONDITIONS AGAINST SHORT TERM E-TENDER No. 10/2024-25

Scope of work: as per BOQ.

Responsibilities of Contractor:-

1. The contractor is required to make them fully conversant with the job required and the work shall be executed as per general conditions of the tender specification contract.
2. The contractor shall be supplying, erecting, testing & commissioning of all materials and equipments not mentioned specifically in the scope of works but required to complete the job in all respect, except excluded specifically for which no extra payment shall be made.
3. The Contractor shall have to arrange all carriage facility including transportation cartages, man power, T&P etc.
4. Any type of NOC (Forest Deptt., Noida/Gr.Noida/Yamuna Authority any other Govt./PSU/Private areas etc.) for the completion of following work will be arranged by the bidder itself only, Department will not be liable for these NOC.
5. Tenderes are advised to visit the sites/Areas of divisions before offering their rates.
6. Illumination/Lighting of working site shall be in the scope of contractor. Nothing shall be paid by the PVVNL.
7. JV's firms are not allowed for the tender.
8. Safety of Man & Material shall be ensured by contractor.
9. The contractor shall ensure that the work is carried out as per NGT Norms/Standard and in such a manner that all premises always look Neat & clean, Similarly, the waste disposal is also carried out in totally sealed manner without affecting the Environment.
10. Contractor shall have to deposit a security Amount @ 10% of the value of Awarded Contract in the form of FDR/PBG pledged in favor of **EE, EUDD-3 NOIDA at EUDD-3 NOIDA** at the time of generating PO in SAP_ERP by Division. Validity of Security amount shall be 01 Year. Security Money shall be returned/refunded after work completion and NOC issued by the concerned division.

Taxes:-

Others Terms & Conditions:-

1. The work will be done under the Supervision of S.D.O./E.E. of concerned division.
2. The charges for Road cutting, Forest Clearances charges, land lease charges or from any other agency which are required to complete the work shall be paid by the contractor, except other than items mentioned in BOQ.
3. Shifting/Loading/Unloading of New/Old material from store to site and back by using the crane and truck of requisite capacity will be done by the contractor on its own cost.
4. The Contractor shall have to arrange all carriage facility including transportation cartages, man power T&P etc on its own cost except other than carriage mentioned in BOQ.
5. The Contractor shall make adequate Arrangement for proper Handling of Material to avoid any Damage/Loss/Accident etc of any kind and Damaged and Removed material and Spares parts will be retained by department.
6. No T&P will be provided by the department. The Contractor shall arrange all the T&Ps. Equipments. Welding set, generator set etc. required for carrying out the above work at his own cost.
7. The contractor shall be fully responsible for any loss/thefts/damaged/accidents the material of the departments and accordingly, he shall have to keep adequate watch and ward to avoid any loss/thefts/damages/accidents etc. to the material of the PVVNL.
8. Work may prolong due to bad weather condition or power Block constraint. Contractor has to negotiate with the prevailing conditions, nothing will be paid extra.
9. Any loss or damage to any of the public utilities shall be replaced/repared by the contractor at his own cost.
10. Managing of site by guard shall be in the scope of contractor
11. The contractor will purchase the material as per PVVNL approved GTP/technical specification. The Final GTP of the material will be as per PVVNL.
12. Material purchased by the Contractor/Agency/firm shall be inspected by the competent committee of PVVNL before supply of material for which an inspection shall will be made by the contractor to competent committee authority P.V.V.N.L. through S.E., E.U.D.C-II, Noida
13. The Contractor shall provide all the facilities (machine & tools etc) to inspecting team in order to check the quality of work. All the expenses shall be borne by the contractor for quality check work. No extra charge will be claimed by contractor.

14. All those petty materials not appearing in the prices schedule but are required to complete the work as per Bill of Quantity / Price Schedule, shall have to be arranged by the contractor at his own cost. Similarly any work activity not specifically indicated but is required for systematic execution of job as per Bill of Quantity / Price Schedule, shall also be done by the contractor for which no separate payments shall be made. Any other misc. work required for proper completion of work shall be done by the contractor.
15. For repairing and overhauling of all the spare parts required to be replaced/repared will be provided by the contractor and the entire repairing/overhauling work shall be carried out the site.
16. The work will have to be carried out strictly as per Indian Electricity Rules & RESPO specification and guidelines and relevant drawings, subject to modification as per site conditions.
17. Videography or Photography (with GPS Location) of site shall be done by the contractor before start of work and after its completion, cost of which will be borne by the contractor and send the progress by electronic media time to time as work progress to the SDO and J.E.
18. General Conditions of Contract Form 'A' & Form 'B' and Standard Contract Conditions of UPSEB/UPPCL/PVVNL/SE EUDC- 2 Noida shall be integral part of tender specification.
19. During the period of work in progress, the Contractor shall have to provide lighting arrangement sign board etc or necessary precautionary arrangement so that accident/ damages/ losses to the public/ manpower of the contractor/ department etc. are avoided.
20. The contractor shall have to execute the work within the stipulated time period as provided in the order issued by the competent authority.
21. If the Contractor Fails to execute the work within the stipulated period, the order placing authority reserve the right to get the work done departmentally or through any other agency. The Excess expenditure, if any, incurred in this connection plus 15% supervision charges shall be debited from the Contractor and it will be recovered from the Security Amount/Running/Pending Bills or through any other credit pending with UPPCL/PVVNL of the Contractor.
22. A Penalty @0.5% per week for Delay/Late in Execution of work shall be payable by the contractor on the total value of contract. The maximum penalty leviable shall not, however, exceed 10% of the value of the work not executed.
23. Depending upon the site conditions, the individual quantity of any item /work may vary up to any extent but total value of the work shall not $\pm 10\%$ exceed beyond the Agreement Value.
24. The Proper Shut down will be taken as required by the Contractor time to time as per site/system Requirement and Availability by the SDO/JE of the Concern Area.
25. Work will be done by the labour of contractor using safety equipments which provided by the contractor at his own cost.
26. Proper skilled staff included Supervisor capable for execution of the above work shall have to be arranged by the contractor. The safety of labour while at work shall be the responsibility of the contractor and any compensation to be paid to them on any account, whatsoever, shall also be responsibility of the contractor UPPCL/ PVVNL shall not be liable for any such compensation etc.
27. The Consignee of the material will be Executive Engineer of concerned division.
28. Process for Payment of work and material shall be done by the Concerned Executive Engineer of the Division where work was done as per departmental norms after the complete execution of work/entire project & submission of executed estimate and after getting satisfactory report and measurement in all respect by concern J.E. and S.D.O. Payment will be made by the PVVNL HQ after availability of funds.
29. Income Tax, TDS, GST-TDS, Labour Cess and all other taxes shall be deducted from the bills of the Contractor as per rules prevailing of Central Govt. at the time of payment.
30. In case it is found that the tender as submitted forced/fictitious documents along with the tenders, his offer will be cancelled and earnest money will be forfeited. Also the Contractor can be black listed for tendering for work.
31. The payment of royalty levied by state/central/other institutions on minerals and other conditions issued time to time by the Government shall be the responsibility of the contractor. The authority shall be free to take appropriate action without any notice in case of non compliance/ non submission of documents of the said payment.
32. The contractors have to furnish his rates including Labour Cess @ 1% the same shall be deducted from the bills of the contractor. The royalty charges levied by stats/central govt. on & other terms 2 conditions issued time to time by govt. shall abide by minrally shall be paid by contractors and its proof shall have to be submitted to Noida.
